- That the personnel take into account the security measures and that all use the appropriate equipment as suggested by the standard.

1.2 Problem

Personal protective equipment is an important role for all workers providing greater safety and for the prevention of an accident that may cause harm to health. For this reason, in order to avoid major social consequences, an integral approach to protection against risks is necessary, including the implementation of measures whose development corresponds to areas of action that are not strictly environmental but have the capacity to perfect the defense and the fight against some risk.

DE C.V. it is a little affected since not all the personnel that carry out risk activities do not use the full personal protective equipment or some do not carry the adequate equipment. 1.3 Hypothesis

1.4 Objectives1.4.1 General Objectives

Propose guidelines to implement safety and hygiene measures to the selection, use and management of personal protective equipment for the formation of a good prevention system for agents of the working environment that may damage their physical integrity and health.

1.4.2 Specific Objectives

- Search and create strategies to prevent and avoid accidents and / or work-related illnesses.
- Create additional formats and carry out activities or tasks to comply with NOM-017-STPS-2008 regarding safety and hygiene in the company TRAJES INIGUALABLES S.A. DE C.V.
- Establish minimum requirements for the employer to provide workers with the personal protective equipment they must use based on the work risks to which they may be exposed due to the activities they develop or the areas where they are located.
- Identify and indicate the areas in the work center the risks where the mandatory use of personal protective equipment is required, in addition to placing an instruction manual that must be followed by the operator.
- Train staff for the correct use, review at the end of cleaning, maintenance and protection of personal protective equipment.
- Supervise that workers use personal protective equipment during their work day.

 Establish a set of Safety Standards that must be adopted to prevent such risks.

2. Theoretical framework Personal protection equipment (PPE)

The EPP are elements of individual protection of the worker, very widespread and used in any type of work and whose effectiveness depends, in large part, on its correct choice and proper maintenance thereof, is designed to protect the person against the risks that may occur in work activities or contact with chemical, radiological, physical, electrical, mechanical or other hazards preventing the occurrence of accidents and personal injuries among employees of the organization (Mexicana, 2008).

The EPP is mandatory use and responsibility of each worker for which the company is required to provide free of charge the appropriate PPE to each of the employees corresponding to the work activities that are carried out in their facilities (Landa, 2017). It needs to be reviewed and inspected periodically to verify its validity, state of conservation and proper functioning (Granda, 2016). The people who perform a task must have a prior evaluation of the position that necessarily includes a survey of hazard identification and a risk assessment to establish which type of PPE is truly appropriate for each task.

The PPE required for each activity should be available in the operation areas so that the task can be initiated only if the staff has the appropriate PPE for their industrial task design. It is the responsibility of workers and supervision to ensure the correct use of PPE in the work areas of each organization (Montanares, 2016).

Advantages:

- It provides a barrier between a certain risk and the person.
- Rapidity of its implementation.
- Improve the protection of the physical integrity of the worker and reduce the severity of the consequences of a possible accident suffered by the worker.
- It is an indispensable element, because it will be comfortable for the worker since it counts as an important factor in the work environment and that its use will protect his physical and mental integrity.

Proper equipment for their personal protection

- Eye protection: Provides safety for the face and eyes in areas where its use is likely to prevent or reduce related injuries. These areas are typically located where the operation with the equipment presents flying particle hazard, direct or reflected brightness, hazardous liquids or any combination of these hazards.
- Protection of the head: It must be provided where there is danger of impact and penetration of objects falling or flying.
 Particularly dielectric safety helmets guarantee accidental contact with energized circuits head protection.
- Protection of the feet: The safety footwear must protect the foot of the workers against moisture and hot substances, against rough surfaces, against footprints on sharp objects, against falling objects, likewise it must protect against electrical risk.

- Hand protection: Hand protection must be provided when there is a danger of cuts, such as when handling blades or cutting tools; when contact or handling of materials at high temperatures, or when there is a danger of contact with power lines, corrosive materials and other dangerous chemicals and solvents.
- Hearing protection: Hearing protectors are personal protection elements used to reduce the noise perceived by a person in a noisy environment. It is mandatory that hearing protection be used when they are exposed to continuous daily equivalent levels greater than 90 db or 140 db.
- Respiratory protection: Respirators should be used to:
- Reduce exposures while implementing other controls.
- Provide protection during activities such as maintenance and repairs when other controls are not practical.
- Provide protection during emergencies.
- Safety belts for work at height: Most fatal accidents in construction are due to falls from a certain height. When it is not possible to perform work from a scaffold or ladder, or from a mobile access platform, the use of safety harness may be the only means of preventing serious or fatal injuries.
- Back protection girdle: It serves to prevent injuries in jobs with lifting materials of more than 20 kg. Some concepts related to work must be considered.

 Protective clothing: It is the special clothing that should be used as protection against certain specific risks and especially against the handling of caustic or corrosive substances and that do not protect ordinary work clothes.

3. Methodology

The method that was used was the field research method because a solution to a problem was given within the company Costumes Inigualables S.A de C.V. in the lack of personal protection equipment analyzing the place and the risk points to which they can be presented for the safety of the worker, the correct equipment was selected for each area and at the same time informing each worker their importance to use the equipment during their operations with the purpose of creating a habit of occupying them for the security of each one.

3.1 Kind of investigation

Within the elaborated project it is considered that the type of research that was used was that of Investigation-action since it is a type of applied research and destined to solutions to problems that have within a group, area or an organization as it is in this In this case, the problem of the lack of personal protection equipment, in addition to having used participatory research which is a study that arises from the problem that originates in the same organization with the aim that in the search of the solution the level of life of the people involved taking into account their participation of each one to achieve the desired objective.

3.2 Theoretical Methods

Personal protective equipment constitutes safety in the workplace and is necessary when the hazards have not been completely eliminated or controlled by other means.

Identification of potential risks according to activities that are developed

The risk is the possibility of suffering a damage to health, elements or dangers. In the activities carried out by the workers, there are risks to the operations, which is why the risks derived from the activities of the jobs were identified. these risks were evaluated considering the areas and activities they perform, the determination of the protection was made considering the "table 2" with which the equipment required to protect the worker was selected from the potential risks identified in each step of the execution of a task; as well as the agents and health risk factors identified in the performance of their activities or in the work area.

4. Results

Personnel that perform work as maintenance or warehouse, must have at least industrial footwear with cap and girdle, in addition to the equipment required for the development of their functions.

Today in the company TRAJES INIGUALABLES S.A. DE C.V. workers make proper use of personal protective equipment due to the knowledge of each of their functions, making workers observe the importance of wearing personal protective equipment for their safety in accordance with NOM-017-STPS-2008, as well as different activities that are carried out within the workplace.

5. Conclusions

The content of the project, developed together with the information obtained, led to the conclusion of the activities that are carried out at TRAJES INIGUALABLES S.A.
